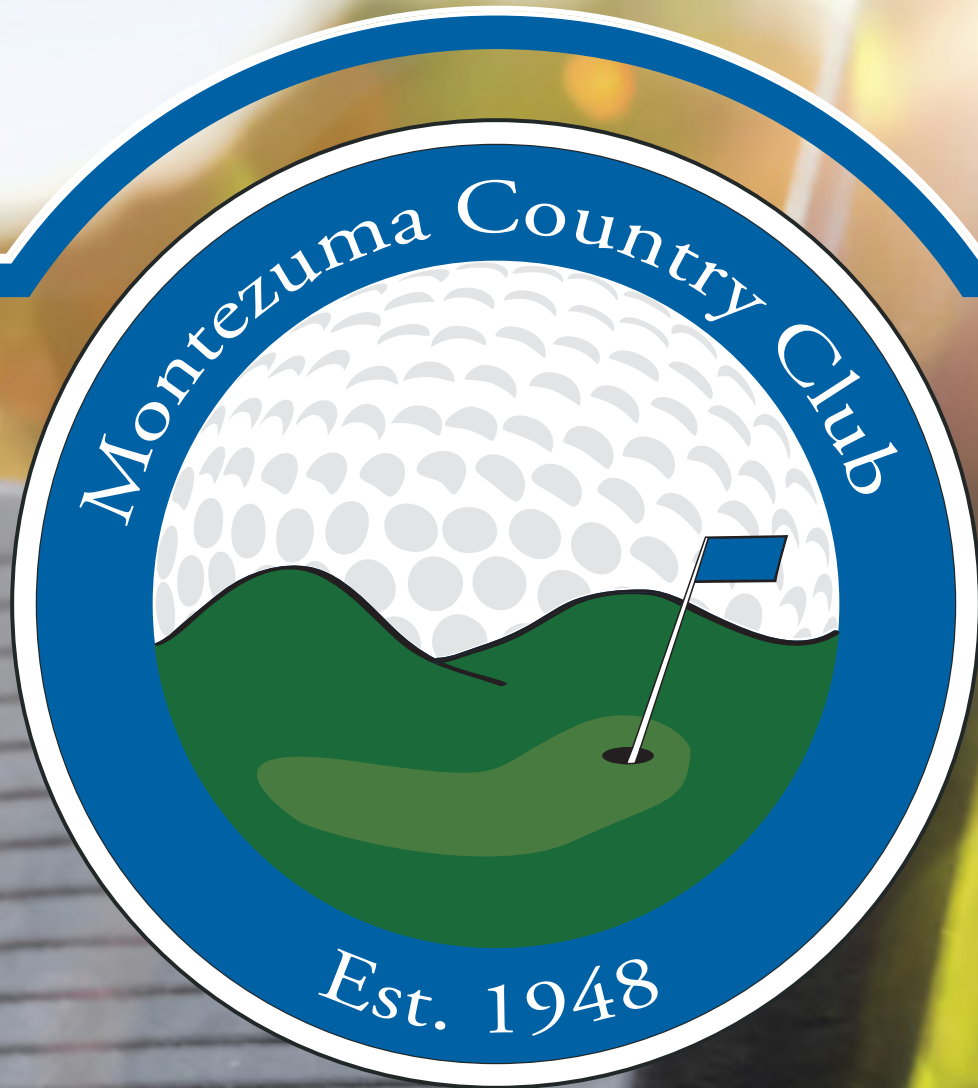
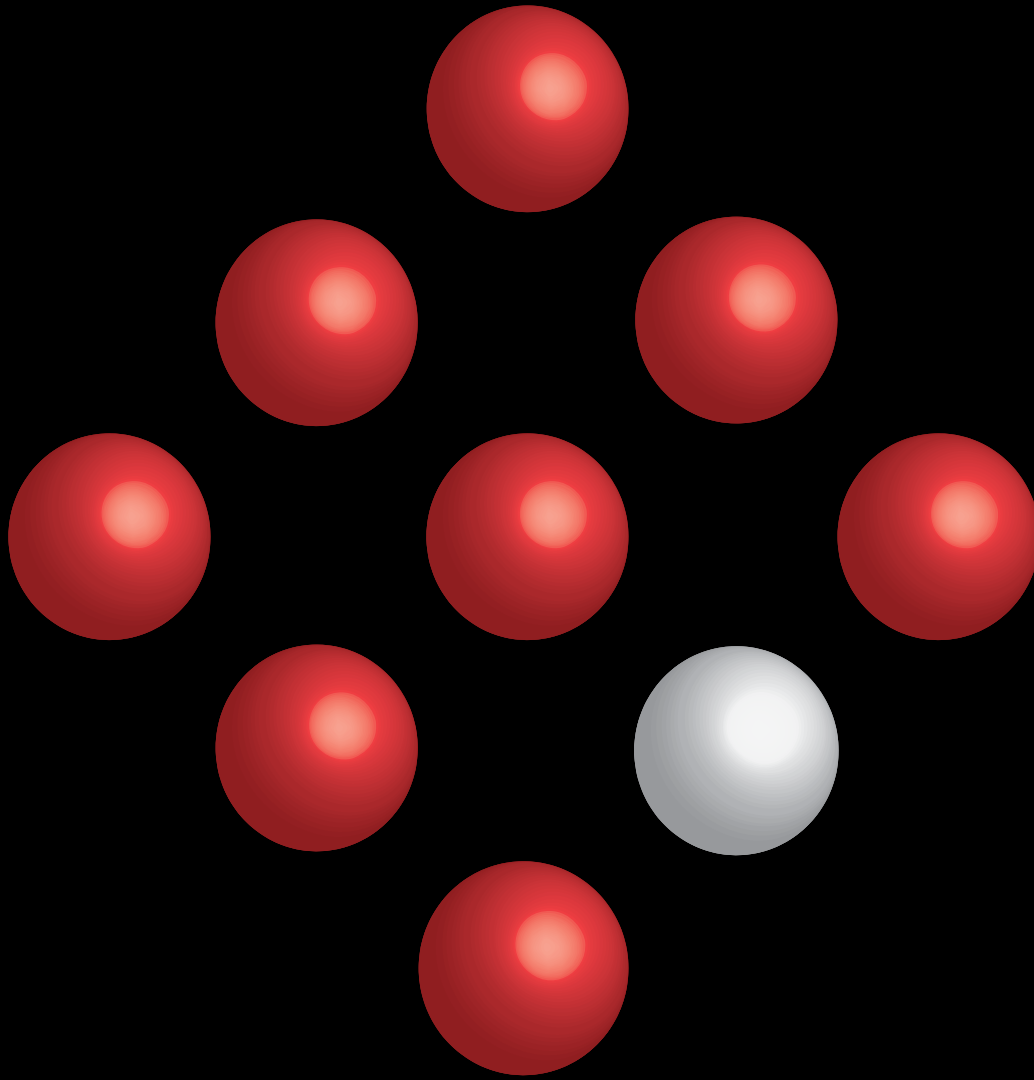

No club functions may be canceled or added without the consent of the Board of Directors. Clubhouse rental or reservations are to be made with the Clubhouse Manager and a form completed.

Tentative pool schedule is Memorial Day to Labor Day but is not guaranteed due to weather, chemical and maintenance issues.

Members are responsible for finding replacements for their designated calendar assignments. If you do not, you may be subject to penalty of payment of exemption fees.

***if you do NOT work your assigned committee and do NOT find a replacement you are subject to be invoiced the appropriate exemption fees for the current season.**

CLUBHOUSE, POOL and CART RENTALS:

Clubhouse may be rented by members for \$100.00 & non-members for \$200.00 per day, along with a Bartender charge at the cost of \$75 for 5 hours. Clubhouse rental is subject to Board approval. Any exemptions from this fee structure must be approved by the Board. During golf season, the clubhouse will remain open to golfers when the club house is rented.

NO OUTSIDE BEER OR LIQUOR IS ALLOWED ON THE PREMISES

POOL PARTY RENTAL: \$75 for members/\$150 for Non-Members plus \$10 per hour for a lifeguard. Maximum of 3 hours

NON-CLUB GOLF FUNCTIONS: A flat fee of \$1,000.00 is required to close the course for non-club golf outings. To be eligible to close the course, you must be a member of the Montezuma Country Club. Subject to Board approval, the fee must be paid 30 days in advance of the event. Maximum of 3 such events booked per season.

GUEST PRIVILEGES: Green fees for a guest (who must live outside the Montezuma School District) is the responsibility of the member, payable at the Clubhouse, if open, or at # 1 Tee. Swimming guest fees are payable in the Clubhouse or fee slot on outside of the Clubhouse wall near the pool. Swim fee is \$4.00 per day.

*The Club has carts available for rent. You must be 16 years of age with a valid driver's license to rent a Club golf cart. No Child under 14 years of age is allowed to drive a private golf cart without adult supervision riding in the cart.

*A prospective member, who has not played the course before and who resides in the Montezuma School District, may play a total of 3 times before joining. Green fees must be paid. This is not an annual option.

*Pool is for the use of members and their out-of-town guests only. Non-members, regardless of where they live, may not use the pool unless they are guests of a member and the member is present.

All above prices include 7% sales tax as required by law.

2024 MCC GOLF REGULATIONS

All players, guests, and members are required to sign the register in the clubhouse or on # 1 tee if the clubhouse is closed. Guests should retain their receipt from the clubhouse manager or the number of green fee envelope they put their money in on # 1 Tee.

1. Ladies Night is every Tuesday at 3:00 P.M. Course is open to all members if conditions allow. Ladies have the right of way in all instances. Pool closes at 4 P.M.
2. Mens Stag is every Friday at 3:00 P.M. Course is open to all members if conditions allow. Men have the right of way in all instances. Pool closes at 4 P.M.
3. Foursomes have the right of way over all other groups. Play in foursomes whenever possible.
4. Keep golf carts a minimum of 30 feet from all tees and greens. Use cart paths whenever possible.
- 5. There shall be no alcoholic beverages on the club premises which are not purchased from the club.**
6. Metal spikes are prohibited at the Montezuma Country Club.
7. Gold and Pink Tees may be used by men (gold) and women (pink) 65 years and older. This applies to all club events.
8. We ask all members of the club to help enforce these rules. Report any violations to the Clubhouse Manager or leave a note in the money box on #1 Tee. There will be no exceptions to any of these rules.

GOLF ETIQUETTE

1. All golfers are to start on Hole #1 on a first-come basis
2. Replace all divots on fairways
3. Repair your ball mark on the green and one other
4. Players searching for a lost ball should allow players coming up to play through
5. Lost ball is 1 stroke penalty and distance
6. Out of bounds ball is 1 stroke penalty and distance
7. Tall grass to the left of #8 is played as lateral water hazard. Lay out from where the ball entered the hazard with a 1 stroke penalty
8. Unplayable lie is 1 stroke penalty and free drop, but not out of the rough if that's where the ball lies

2024 MCC SWIMMING POOL RULES AND REGULATIONS

1. Pool is for the use of members, their immediate families, and guests of members only. Members are responsible for paying the \$4.00 per person for guests. (Guests are people who live outside of the Montezuma School District) A pool membership DOES NOT include married children and grandchildren.
 2. All members must sign themselves and their guests in before swimming.
 3. Lifeguard is on duty from 12:00 P.M. TO 4:00 P.M. WEEKDAYS. The gate will be locked when the lifeguard leaves unless a responsible adult is present. **You must be 16 years of age and have filled out the pool waiver to swim when a lifeguard is not present for any minor child. This waiver also allows 16+ to bring younger SIBLINGS during non-lifeguard hours.**
 4. The lifeguard has absolute authority to ask any person to leave the pool area at any time, for any length of time, for misbehavior or failure to obey rules and regulations.
 5. No diving, no rough tactics (dunking, pushing, water fighting, etc.)
No running on the deck around the pool, or to and from the shower rooms.
No riding of float rope separating the shallow and deep ends.
 6. Showers should be taken before entering the pool.
 7. Older kids who swim must stay in the deep end when younger children are in the shallow end.
 8. To be left with the lifeguard, children must be 5 years old and able to stand in the shallow end with their chin above the water. NO EXCEPTIONS.
 9. When the lifeguard is on duty, a rest period of 5 minutes every hour on the hour will be taken. Everyone must be out of the water during this time.
 10. No glass containers or popcorn around the pool at any time.
 11. Toys and balls are allowed in the water at the lifeguard's discretion.
 12. Any time the lifeguard should need to leave the pool area, everyone must be out of the water.
 13. You must have a pool membership or pay a guest fee to sunbathe.
 14. Non-member babysitters must be accompanied by member's children to be allowed at the pool.
- * Failure to abide by the above rules may result in the loss of swimming privileges.**

MONTEZUMA COUNTRY CLUB CODE OF CONDUCT POLICY - 10 February, 2021

The Code of Conduct Policy has been developed to ensure Article IV, Section 5 of the Montezuma Country Club Bylaws may be equitably applied to members.

As a guiding principle, all members, visitors, staff, and the board of directors are expected to conduct themselves in a manner that creates an environment and culture that is reflective of the attributes of golf: integrity, honesty, and respect. These attributes are expected whether on the golf course, at the swimming pool, or in the clubhouse.

Upon a complaint being made to the Montezuma Country Club ("MCC") board of directors about a member, all such complaints shall be thoroughly investigated by the board of directors. Upon determination by the board of directors that action is necessary, the following disciplinary actions shall be taken in the sole discretion of the board of directors, either as part of the progressive disciplinary process or as an immediate disciplinary action, depending on the circumstances:

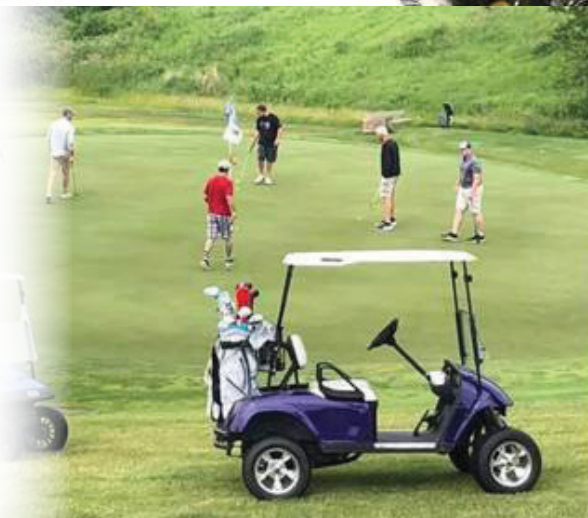
- (1) Verbal Reprimand: A verbal warning for correction of a behavior will be given to the member. The board of directors will write up the member's behavior and the verbal warning will be placed in the member's file.
- (2) Written Reprimand: A formal warning for correction of a behavior problem. All reprimands will be documented and included in the member's file with the member's signature. A written warning may include up to three (3) months of probation.
- (3) Disciplinary Probation: A formally established period intended to give the member an opportunity to improve behavior. The probation period will not be less than three (3) months nor more than twelve (12) months in duration. A formal end-of-period review of a member's probation is required to end a probationary period, and will be completed by the board of directors at the end of probation period and placed in the member's file.
- (4) Suspension: A suspension from MCC shall be at minimum for one (1) month and shall not exceed six (6) months. The member shall not be present for any reason on MCC property during any time or event during the suspension unless a scheduled meeting is set with the board of directors. A formal end-of-period review of a member's suspension is required to end a suspension, and will be completed by the board of directors at the end of the suspension period and placed in the member's file.
- (5) Termination of Membership: Termination or dismissal from membership at MCC as a result of disciplinary action requires unanimous approval of the board of directors. A written statement shall be prepared by the President explaining the circumstances which contributed to the member's termination and filed in MCC's business office and the member's file.

All such disciplinary actions, other than termination of membership, shall be determined by majority vote of the board of directors.

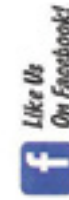
